The Inspection team duly constituted vide letter no. 006/Affili/426/AKU/2021(Vol-III)-2792 dated 13/06/2024 visited Patliputra College of Professional Education, Khemnichak, Patna, on 18-06-2024 and inspected the infrastructural and instructional facilities available in the college for extension of provisional affiliation of BCA and BBA courses with seating capacity of 180 students per year in each of course for the session 2024-25 . Further the college has been granted affiliation from AICTE vide letter no- Northern /2024-25/1-43841478204 date of approval 09 May 2024 for B.B.A. 180 Seats & B.C.A. 180 seats in each courses.

## **Observation:**


The Inspection team physically visited the college and observed that the Institute has infrastructural facilities for extension of provisional affiliation for BCA and BBA courses with seating capacity of 180 students in each courses for the session 2024-25.

## **Suggestions:**

- (i) There must be provisions for Career Enhancement of the faculty members.
- (ii) The existing library must be enriched with sufficient number of books for each course, e-books & e-journals with DELNET facility.
- (iii) There should be provision for green energy (optional).
- (iv) Computer lab needs to be upgraded with more H/W & S/W
- (v) Library should be enriched with computers & management books & latest journals.
- (vi) Conference hall need to modified with LCD projector .
- (vii) The college must maintain the cadre ratio of faculty members .
- (viii) Parking area need to be maintained properly .
- (ix) All the norms and standards of the AICTE shall be followed in the letter and the spirit.

## **Recommendations:**

On the basis of observations and findings after physical verification of the college and documents, the Inspection team recommends that extension of provisional affiliation may be granted to **Patliputra College of Professional Education, Khemnichak, Patna** with intake capacity of 180 students each in BCA and BBA courses for the session 2024-25.
